SECTION 4: TERMS AND CONDITIONS

- 1. Billboards must be erected as per the Roads Authorities standard specifications and Council's street signage specifications.
- 2. No billboard/signage must be installed/erected that is obstructing traffic or visibility of traffic signs or pedestrians or that are obstructing municipal service provisions.
- 3. No offensive or controversial billboards are accepted to be erected in town.
- 4. All road signs must be erected at least 10 meters from the road.
- 5. All gantries must comply with minimum height/elevation above the road.
- 6. Billboards are to be paid as per the existing Tariff Structure or as per the agreement entered into with Council.
- 7. Unpaid billboards will be regarded as illegal and will be removed without notice. An illegal erection of a billboard fee (N\$2,000.00) will be charged.
- 8. Renewal of expired billboards should be done within 60 days of expiration of the agreed term and expired (*no-longer paid for*) billboards will be removed without notice.
- 9. Council reserves the right of admission for the allocation and erection of billboards.
